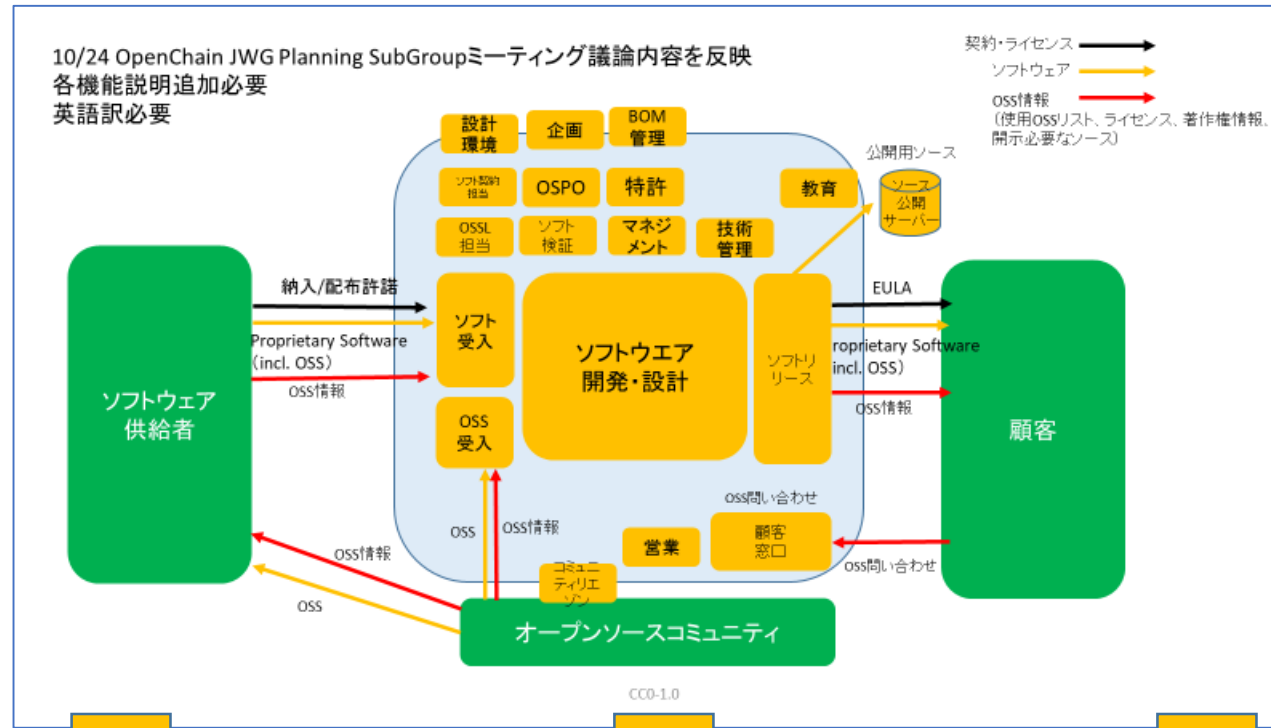

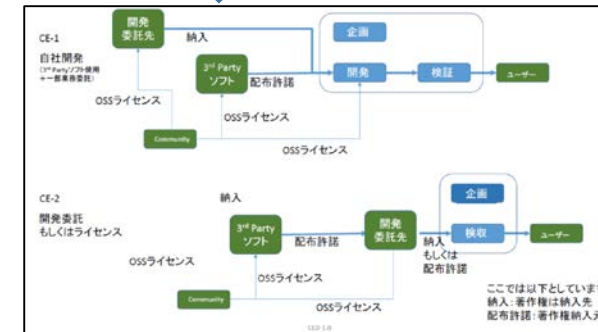
Applying Universal Model

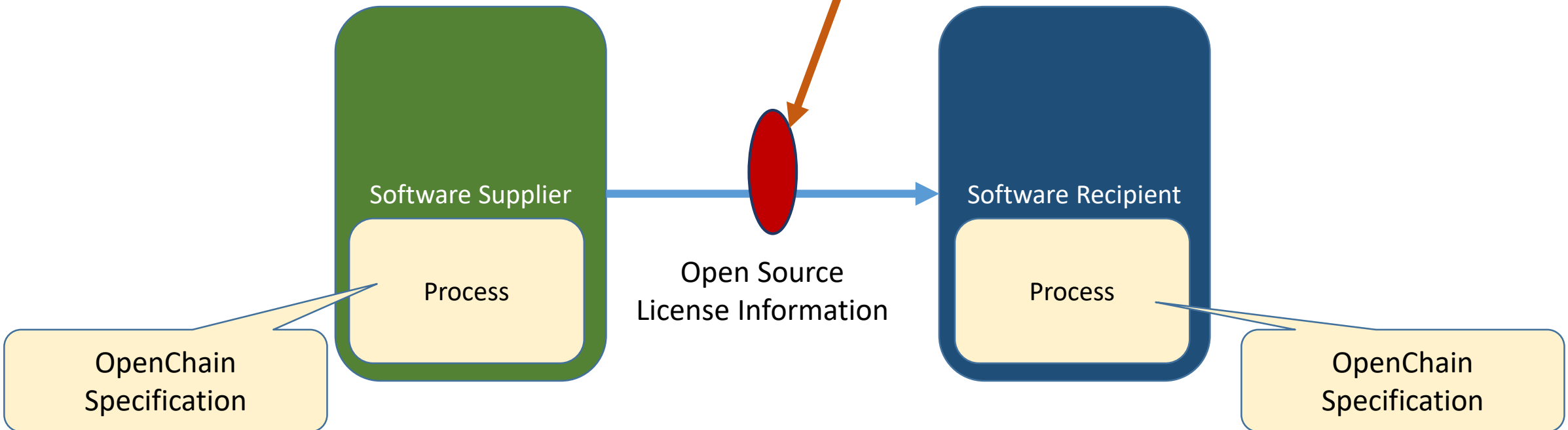
Potentially Building Guidelines for the Exchange of License Information
